OFFICE HOURS WITH COMMISSIONER BOB JANES – On September 26th Bob Janes held office hours at the Pine Island Library. I met with him at that time regarding a paramedic for Station Three. Four or five years ago Chris Hansen, Lee County Paramedic Director, stated at one of the BCA meetings at PIUMC that, “If you build a fire station in Bokeelia we will have a paramedic there.” Most recently I spoke to someone else in that department and was told the placement of a paramedic would depend upon the availability of funds. Since that time Chris Hansen has retired. I explained that there are more medical calls to Bokeelia than fires and I had a solution. Lee County currently provides paramedics to ride on the fire truck in St. James City. Would it be possible to do the same in Bokeelia? Janes stated that since we had a success story it would be a good argument to make this happen. He would discuss it with Hansen’s replacement and get back to me.

MPIFCD – On September 24th after three open meetings regarding the budget, the millage rate was set at 2.85 and the budget was passed with a 3-2 vote. Opposed were Bob Elder and John Cammick. Chairman, Bob Elder, has resigned effective 9-29-08.

UPDATES

STATION THREE – Landscaping, tile work and furniture should complete Station Three some time in November. A grand opening will be planned for January.

STATION FOUR – The property for which Eminent Domain mediation was held September 30th was for raw land and did not include any structures. The hearing was successful and MPIFCD now owns all the properties needed to build Station Four. Included in the deal was a request by the seller that the District not clear the property fronting on Pine Island Road for six months. This was granted to the seller.

SHELL CUT MARINA – USACOE said the marina is still under review until more information is received from Florida Fish & Wildlife and the applicant.

BOKEELIA BOAT RAMP – Gravel has been added on McNeff and to the parking lot to eliminate eight pot holes. Grass has been cut. However, ramp improvement will be subject to funds available.

PALMS AT PINE ISLAND – MAGISTRATE HEARING – Petition for (Treeco Village) for 64 units for migrant worker housing was previously denied. There will be a special magistrate hearing on October 31 in Lee County.

CALUSA COVE – The Hearing Officer rendered a decision in April 7th regarding the variance for paving McNeff Rd. and a decision regarding the maintenance of the road on June 20th. (request a copy of the 38-page final report at bokeeliacivicassn@comcast.net)
